## NGĀI TE RANGI FISHERIES AHC LTD (NFAL)

### TERTIARY EDUCATION GRANT

#### CRITERIA

1. Ngāi Te Rangi Fisheries AHC Ltd (NFAL) has the sole discretion to accept or decline an application. Decisions are final and late or incomplete applications will not be accepted. Funding is limited and grants awarded will take into account those applicants who can demonstrate that they are committed to completing all requirements of their tertiary study.
2. The Tenure for the grant is for **2020** academic year.
3. Grants are available to applicants who are registered members of **Ngāi Te Rangi Iwi only** (*to check if you are registered, ring 07 575 3765*) and applying for full or part time study in New Zealand, all applicants are eligible to apply each year only in accordance with the criteria stated in the Ngāi Te Rangi Fisheries AHC Ltd Policy.
4. Completed applications and all documentation must be received by no later than 4pm on **29<sup>th</sup> April 2020** The Boards decision on the successful applicants will be notified on **11 May 2020**. Unsuccessful applicants will be notified in writing on **14 May 2020**. (*it is important to note that completion of the application does not mean that you will automatically receive a grant/scholarship*).
5. If an applicant withdraws from their course during the year prior to completing their studies they must notify NFAL. NFAL may require the applicant to repay the scholarship funding in part or whole.
6. **Closing date for all applications is 4.pm, 29<sup>th</sup> April 2020** of which all requirements (noted on page 8 of this application form) must be met.

## NGĀI TE RANGI FISHERIES AHC LTD TRUST (NFAL) TERTIARY EDUCATION GRANTS AND SCHOLARSHIPS POLICY

### Statement of Intent:

Ngāi Te Rangi Fisheries AHC Ltd (NFAL) shall succeed in achieving integrated sustainable fisheries management for the benefit of future generations.

To protect and improve Ngāi Te Rangi's legacy in fisheries including commercial, customary and recreational fisheries. To develop the sustainable growth of our fisheries business and operations. To maximise returns to our Shareholder.

### Criteria for Application:

All applicants will be studying towards the protection and improvement in the area of fishing, commercial, customary and recreational as well as but not including the sustainable growth of fisheries business and operations. Grants will be distributed at the discretion of the NFAL Tertiary Education Grants Committee only.

### Purpose of the Policy:

- To set in place procedures for allocation of educational grants/scholarships
- Objective: To assist students financially in their academic endeavours.

**Co-ordination:** Chair on behalf of Ngāi Te Rangi Fisheries AHC Ltd (NFAL)

### Tertiary Education Grants Committee to consist of:

- The 3 Directors of Ngāi Te Rangi Fisheries AHC Ltd. (NFAL)

### Value of Grants:

- Up to \$10,000 per distribution year.
- Distribution of allocated value to be at the discretion of the Tertiary Education Grants Committee.

**Resourcing of Grants:** Ngāi Te Rangi Fisheries AHC Ltd

### Process:

- Applications open 1<sup>st</sup> March year of distribution
- Applications close 31<sup>st</sup> April year of distribution
- Education Grants Committee to allocate grants by May year of distribution
- Results of allocations ratified at next NFAL Board meeting
- All applicants notified of allocation results
- Successful applicants paid out allocated grant upon written confirmation of enrolment at listed Tertiary Institute.

#### A. Applicants Eligibility Criteria:

- An enrolled beneficiary of Ngāi Te Rangi
  - For study at a recognised Tertiary Institute located in New Zealand Only
  - Allocation Criteria: To be used as a general guideline for the Education Grants Committee.
1. Evidence of past achievement
  2. Knowledge of the Fishing Industry/Environment (*Suggested fields on page 10*)
  3. Recipient to be paid in instalments, with qualifying conditions for payment
  4. Recipients expected to provide reports, when and if requested by the Grants committee



5. To be eligible for yearly grants, each applicant will have to submit a Performance Review and reapply each year of their study.
